## SCHEDULE

### 1. PAYMENT OF REDEMPTION AMOUNT AT MATURITY

For the purposes of items 26 and 27 of Part A above, the Issuer shall pay the Redemption Amount on the Maturity Date (subject as provided in item 26 of Part A above and in the Conditions) as determined by the Calculation Agent by reference to the following:

- (i) If a Barrier Event has occurred, then the Issuer shall pay the Redemption Amount of EUR 1,055.00 in respect of each Calculation Amount; or
- (ii) If a Barrier Event has not occurred:
  - (a) If the Underlying Final Level is **equal to or greater than** the Underlying Strike Level, then the Redemption Amount shall be determined by the Calculation Agent in accordance with the following formula:

**Underlying Strike Level** means 3476.63, being 100.00% of the Underlying Initial Level.

**Upper Barrier Event** means that the level of the Underlying has at any time (continuous observation) been equal to or greater than the Upper Barrier Level during the period from (but excluding) the Strike Date to (and including) the Final Valuation Date.

**Upper Barrier Level** means 4171.956, being 120.00% of the Underlying Initial Level.
